DESARROLLO

METAL GROUP is made up of the companies METAL SMELTING and METAL PERFORMERS, whose activity is to provide a comprehensive service to its customers through the manufacture of highly responsible and demanding cast iron parts from 0.5 kg to 3,000 kg, as well as their subsequent finishing, machining and logistics, for sectors such as the automotive industry, compressors, lifting, renewable energies, machine tools, motors, valves, etc.

Aware of the need to be competitive in an increasingly demanding market, our aim is to become a strategic partner of our customers, supporting them from the initial stages of product design to its entry into production, without neglecting the impact that our activity has both for the safety of people and for the preservation of the environment.

For this reason, the following commitments are defined:

- ✓ To ensure the protection of the environment, working in a respectful way, preventing pollution and minimizing the environmental effects produced as a result of the activity we carry out in our centers.
- ✓ To promote research and development of technologies that contribute to the mitigation of climate change and enable the sustainable use of natural resources.
- ✓ To ensure compliance with the applicable legal environmental requirements and other requirements that METAL GROUP assumes as its own.
- ✓ To periodically establish indicators and objectives that allow us to objectively ascertain the environmental impact of our centers in order to ensure the continuous improvement of METAL GROUP's environmental performance, with the same interest with which we pursue economic and social issues.
- ✓ To maintain the awareness and awareness of all our employees, promoting their environmental training and encouraging their active participation, including suggestions for improvement proposed by them in order to promote continuous improvement.
- ✓ To integrate the Environmental Management System into the overall management of METAL GROUP.
- ✓ To carry out a periodic annual evaluation of the environmental aspects derived from our activity, for the purposes of maintenance and continuous improvement of the Environmental Management System.
- ✓ To respect nature and biodiversity in the environments in which METAL GROUP centers are located.
- ✓ To raise awareness, train and involve the Group's professionals, contractors, suppliers and other stakeholders in the commitments and principles of this Policy.
- ✓ Promote the reduction of greenhouse gas emissions that contribute to minimizing our footprint on the environment, as well as making efficient use of energy.
- ✓ Ensure that the maximum possible percentage of the energy consumed comes from renewable energies.
- ✓ Make rational and sustainable use of water, managing the risks related to water scarcity and ensuring that the water used is returned to the environment in the desired condition.
- ✓ Ensure compliance with applicable legal requirements to maintain air quality.

- ✓ Make responsible use of all natural resources and promote the reduction of waste generated.
- ✓ Make responsible use and management of all chemicals used.
- ✓ Conduct regular audits and assessments of our management system to ensure its effectiveness.
- ✓ Likewise, the identification and evaluation of environmental aspects allows the company to maintain an environmental management based on 3 pillars:
- ✓ Precaution: avoiding actions that may involve an environmental risk, regardless of how serious they may be if they materialize.
- ✓ Prevention: avoiding the environmental consequences associated with a given action.
- ✓ Correction: foreseeing how to counteract the environmental consequences of a risk should it materialize.

All of us at METAL GROUP accept these principles, and it is our responsibility to put them into practice.

METAL GROUP promotes environmental improvement and allocates the necessary resources to ensure the successful implementation of this Policy, which applies to all METAL GROUP activities, products and services and is reviewed annually to ensure its ongoing suitability and consistency with our objectives, guaranteeing continuous improvement.
